## Background

The achievement of the 2030 Agenda for Sustainable Development and the SDGs requires different sectors and actors to work together in an integrated manner by joining forces, sharing knowledge and providing expertise. The COVID-19 pandemic has underlined the importance of enhancing collaboration and effective partnerships among all sectors and stakeholders, as well as mainstreaming environmental and climate change issues to increase resilience, in designing and implementing response, recovery and rebuilding-better strategies and measures. National and local governments, civil society, the business sector, financial institutions and UN agencies must work together through active partnerships to support a green recovery that also builds transboundary and subregional cooperation and accelerates progress towards the SDGs, especially on climate action through Nationally Determined Contributions (NDCs).

The purpose of this session is to share experiences and examples of partnerships at country and subregional levels on responding the COVID-19 pandemic and building back better, and to discuss how to enhance the collaboration between the UN system, governments and others, including through NDCs. The session will highlight coherent approaches to targets within SDGs 1, 2, 13 and 17 (specifically, 1.6, 2.a, 13.1, 13.2, 17.7, 17.14, 17.16 and 17.17). It will also build on examples from a compendium of measures to green the post-pandemic recovery prepared by the United Nations Inter-Agency Issue-based Coalition on Environment and Climate Change for Europe and Central Asia.
